Consignment Contract

Thank you for choosing Dressed to a T, LLC! The following are the terms and conditions of the consignment agreement between Dressed to a T and the consignor.

All items will be displayed for 12 months. Items on contract cannot be sold outside of Dressed to a T during this time. A \$10 early pull fee will be assessed if you decide to pick up your items prior to the end of this contract. An option to renew the agreement will be at the discretion of Dressed to a T, LLC. Ownership of all items is retained by the consignor during the agreement period, and while Dressed to a T, LLC is careful and trustworthy, we assume no liability for theft, fire, flood, natural disaster, loss or damage to consigned items. The items are being handled and tried on. You should expect some wear. If damage does occur to your item(s), we will contact you right away to see how you would like to proceed.

All items must be cleaned and free of odors and pet hair. Items must have no stains, holes or runs, missing buttons or hooks, no missing beading, no broken zippers or torn/loose hems or seams. **Items in need of repair or cleaning may incur fees that will need to be paid in full before the items go on the selling floor.** Garment bags, hangers and packaging left with Dressed to a T, LLC will not be returned to consignor.

Item placement is subject to available space and Dressed to a T, LLC reserves the right to refuse consignment of items if we feel that the items are something that we cannot sell.

Dressed to a T, LLC will price your items based on age, condition, brand, style, size and demand. We also reserve the right to discount as needed. If you have a minimum you will accept for the items being consigned, you must notify us prior to entering into this consignment agreement and it must be pre-approved by a staff member at Dressed to a T, LLC. All estimates of selling values are opinion only and shall not be construed as any promise to sell or promise to sell items at any set price. Dressed to a T, LLC agrees to use its best efforts to sell all items consigned in a timely fashion and for the highest price possible. By signing this agreement you allow Dressed to a T, LLC to photograph your items and promote them.

The consignor will receive 40% of the price the item at which the time was sold excluding sales tax. Please keep track of your items by logging into your account (see below), calling or texting the store. Once items have sold, you may request a check by stopping in at the store or mailing a self addressed stamped envelope. Checks will be forfeited to Dressed to a T, LLC after one (1) year uncashed / unclaimed.

Dressed to a T does not notify you when your contract ends. Please make note of the end of this contract or log in to your account to view the status of your items. You will have seven (7) days to pick up your items after the end of your contract. After the seven (7) days, if your items are not picked up, they become the property of Dressed to a T, LLC and may be donated to a local charity.
